My Catawba County is an all purpose mobile web application developed to provide the citizenry of Catawba County with a greater ability to stay informed about the news and services provided by their county government. Since *My Catawba County* is a mobile web application, it is supported on all major platforms that have internet access and a web browser including, but not limited to: iPhone, iPad, Android phones and tablets. It uses location based technology so GPS/GPS Satellites/Location Services need to be turned on to get the most benefit from the app.

Perhaps the most beneficial aspect of *My Catawba County* is the Citizen Service Locator. The Citizen Service Locator provides users the ability to find the location, distance, description, address and callable phone number of many services provided by Catawba County and its cities. Currently, these services include: Law Enforcement Offices, EMS Bases, Fire/Rescue Stations, Libraries, Parks and Animal Services adoptable animals listing. Once a user chooses one of the aforementioned categories, they have the option of choosing between a list view and map view. If a user chose the "Parks" service and then chose "Parks List", they would be provided with a list of all parks within the county and the distance from the user's current location sorted closest to farthest. The user then has the ability to choose any park from the list and find out additional information about that park (i.e.: what activities can be done there, contact phone number, address, description and view pictures). If a user had chose the "Parks" service then chose "Parks Map", they would be provided with a Google Map and map markers showing all the park locations within the county along with a blue user marker showing the users current location. The blue user marker will constantly follow the user and this gives them the ability to see what parks they are close to and where they are within the county. If the user is interested in learning more about a location, they can click the map markers and find out more information. Additionally, a complete set of Administrative Tools are available so that an admin can add a new category (i.e: Recreation Centers, Government Buildings, etc.) and add as many points of interest to that category as they wish. In other words, new Citizen Service Locator categories and places can be easily added by an admin without seeing a single line of code.

Another feature of the Citizen Service Locator is the ability to activate Red Cross Emergency Shelter locations throughout Catawba County in case of an emergency. These shelters are controlled and activated dynamically through a set of Administrative Tools on a server that is accessible by Emergency Services. Since it is only typical for a few shelters to be opened in an emergency situation, administrators have the ability to dynamically activate certain shelters throughout Catawba County.

When these shelters are activated, they have the same list and map view functions of the other citizen services and provide citizens with a method of discovering information about particular Red Cross Shelters and finding their location and distance through the map and list view functions.

Other popular features built into *My Catawba County* include a large social networking hub that will allow users to easily discover all of Catawba County's Governments news and activities from one centralized location. These include: Catawba County's five Twitter Feeds, four RSS feeds and an external link to our mobile Facebook, mobile YouTube and "Who's In Jail?" page. Some of the more interesting feeds would be the 911 Traffic Accidents Twitter feed, Emergency Management Twitter feed, Job Openings RSS Feed and the Adoptable Animals RSS Feed.

The *My Catawba County* mobile web application was mentioned in most all local Catawba County newspapers, The Charlotte Observer, and multiple government technology websites.

“MY CATAWBA COUNTY” BRINGS GOVERNMENT INFORMATION TO MOBILE PHONES

“My Catawba County”, a new service for users of mobile phones, has been launched. Anyone accessing My Catawba County will be able to choose from a selection of informational links and County applications. The service may be reached at <http://m.catawbacountync.gov/mycatawbacounty/>.

The application was developed for mobile devices with a web browser such as iPad, iPhone, Android phones and tablets. Google Chrome is recommended for those wishing to use a desktop browser.

“Catawba County is constantly looking for new ways to interact with and get information to its residents,” said Terry Bledsoe, Catawba County’s Chief Information Officer. “With technology like the Smartphone and location based services, information that was available on our website takes on a new dimension. Users may find information in real time based on their location. With this, finding the nearest park, getting accident information, or finding the nearest fire department or EMS base becomes easy. My Catawba County puts useful information at your finger tips, anywhere, anytime.”

Users who first access My Catawba County will be able to choose from nine links. These include Citizen Services, NCDOT Alerts, Traffic Accidents, Job Openings, Who’s In Jail, and connections to Catawba County’s social media outlets through Facebook, Twitter, RSS feeds, and YouTube.

The Citizens Services link will take users to another menu of choices for information about parks, libraries, law enforcement, fire and rescue services and Animal Services. It will also allow users to find Red Cross emergency shelters should they be opened in an emergency situation. The NCDOT alerts will point users to a feed maintained by the North Carolina Department of Transportation that lists traffic alerts/congestion reported across Catawba County, while the Traffic Accidents link takes users to the County’s Twitter feed on accidents and roads conditions in Catawba County.

Selecting the Job Openings button will redirect a user to the page listing job openings with Catawba County and the process that an interested person should use to apply for a job with the County. The Who’s In Jail link provides a connection to one of the most visited sites by those entering the County’s internet “front door”. It gives information on persons who have recently been arrested and the charges filed against them.

A majority of the information about Catawba County that is released to traditional media outlets and on www.catawbacountync.gov is also distributed on the County’s Facebook and Twitter feed. My Catawba County users may find it more convenient to get to those pages via the new mobile app.

“I hope the new app enables citizens to become more informed about the many services offered in Catawba County,” said Jason Eades, the principle designer of My Catawba County. “Whether it’s finding a new park in the area for children to enjoy or helping citizens find a Red Cross Shelter in case of a disaster, I hope My Catawba County does something to help the people here.”

» **Catawba County, N.C., Website Goes Phone Friendly**

Catawba County, N.C., relaunched its official website <http://www.catawbacountync.gov/> in late June, and like many recently redesigned government websites the county is catering to the modern Web user by providing a mobile version.

The new version of Catawba County's site, called "My Catawba County," is now accessible on multiple mobile devices such as iPads, iPhones, Androids and tablets.

"With technology like the smartphone and location-based services, information that was available on our website takes on a new dimension," said county CIO Terry Bledsoe in a statement. "Users may find information in real time based on their location."

Through the mobile version, users can locate places in the county such as parks, libraries and animal services. In addition, the site provides alerts from the North Carolina Department of Transportation, alerts on traffic accidents, job openings and through the "Who's in Jail" feature, can access a list of county inmates recently incarcerated. The listing shows the inmate's name, the date he or she was confined, the charge, bond amount, court date and other details about the inmate.

The county also made social media sites accessible through the mobile version so users can reach the county's Twitter, Facebook and YouTube pages.

Catawba County's [announcement](#) comes at the heels of some state governments making similar changes..

In May, Arkansas [announced](#) the relaunch of its official website Arkansas.gov to include mobile access and on June 23, Virginia made a similar move and launched a revamped version of its website Virginia.gov to include more social media features as well as a mobile site.
